#### STATEMENT FROM THE CHAIRMAN ACADEMIC YEAR 2020 (7/19 - 6/20)

Dear Colleagues and Friends:

I am pleased to share with you the Annual Report of the Department of Medicine at the University of Florida-College of Medicine - Jacksonville for the academic year July 2019 through June 2020. Despite the challenges created by the pandemic of Covid-19, the faculty and staff showed upmost degree of resilience and dedication and we were able to accomplish many of our goals. I will briefly describe the departmental accomplishments in our tripartite mission of excellence in patient care, education and research.

**Patient care**: Clinical volumes in all specialties was increasing up to the end of March 2020 when social distancing mandate along with patient concerns of the safety of clinic environment caused 35% reduction in patient encounters. Because of these challenges, Telehealth was implemented across all subspecialties. It is likely that this option of patient encounters will continue to be offered as many patients have expressed deep satisfaction with the newly implemented technology. Despite the challenges, the Department finished the year with a positive balance of the budget of \$976,214.

**Education:** The Department continues to excel in its mission of educating students and residents. There were unprecedented 36 faculty members in the Department who received the Exemplary Teacher Award. In addition, several faculty members and trainees in the Department of Medicine received key education awards. Dr. Taylor Palfrey received the Rosilie O. Saffos Outstanding Resident Teacher Award and Dr. Khadeeja Esmail received the Edward Jelks Outstanding Resident Clinician Award. Our annual continuing Medical Education (CME) initiatives were cancelled this academic year because of the pandemic.

**Research:** The Department once again had a productive year in research. There were 165 peer-reviewed publications, 18 monographs and book chapters. Faculty made 113 national and 29 regional presentations. During the academic year 2020, we had 81 research awards. The scholarly productivity of the house staff remained high with 34% of all the presentations at the Annual Research Day were made by the residents and fellows within the Department.

Despite the challenges related to the pandemic, the Department excelled in every aspect of the academic mission. Our general internal medicine faculty and the critical care faculty along with our trainees were in the frontline of caring for patients with Covid-19 infections. Many of our subspecialists and advanced care providers volunteered to be back up providers for these patients. I am proud and humbled to have the privilege of serving as the Chairman of such an exceptionally productive Department.

#### **GRADUATE MEDICAL EDUCATION** ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

This academic year has had challenges due to the COVID-19 pandemic. Despite these trying times that had major impacts on the latter half of this year, the program continued to flourish and enjoy lots of success. The program continued to pursue excellence in in several areas, including scholarship, board pass rate, quality improvement, and fellowship match. The fellowships continue to produce high quality physicians, and the newest fellowship, rheumatology, has matured into a highly competitive training program. The core residency program remains strong in graduating residents who will support the community and fellowship remains a desirable future for the majority of our trainees.

At the Annual Program Evaluation, the program reviewed components of its Self-study, including the program's SWOT analysis and Aims. In particular, the program Aims were reaffirmed and deemed reflective of the academic mission of our residency program. They remain as follows:

- □ Produce competent, independent practicing internists, who have the ability to comprehensively care for patients in both inpatient and outpatient settings
- Prepare competitive resident applicants for fellowship, who have the opportunity to pursue other interests beyond internal medicine. This may include scholarship, education, advocacy, or leadership
- □ Train practitioners to have a basic understanding of quality improvement and patient safety
- □ Produce residents who will serve the local community through their practice of primary care, hospital medicine, and medical subspecialties. These practitioners should have expertise in treating the variety of patient populations in our community, with a particular understanding for the medically underserved.
- Develop well-adjusted residents through a programmatic focus on physician well-being. The intent being that emotionally healthy physicians will be more resilient and able to deliver the best care to our community.

The residency graduating class of 2020 was diverse in their destinations following graduation. Seven of our graduates sought fellowship training in the subspecialties of cardiology, gastroenterology, pulmonary/critical care, infectious diseases, and endocrinology. While some graduates pursued fellowships at other institutions, four residents are staying in Jacksonville for fellowship. Others have pursued hospital medicine in the Southeast and Southwest regions of the country.

The class of 2019 was very successful on the American Board of Internal Medicine examination achieving a 100% pass rate. This brings the ABIM three year rolling average to 95%, in line with the national average. The program continues to provide trainees with a plethora of board preparation materials in addition to high quality clinical training; we expect the entire class of 2020 to pass the exam.

The leadership within the residency program remained stable for the past academic year. Drs. Kevin Green and Peter Staiano continued the tradition of strong Chief Resident teaching and leadership. They continued to build on the strong foundation from their predecessors that included the continuation of Research Club. The Research Club is a forum for trainees to present new ideas and proposed projects in front of seasoned faculty, research professionals, and fellow trainees to solicit advice and feedback before embarking on a new research endeavor. In addition, they helped develop an ultrasound curriculum (bedside echocardiography, pulmonary, renal and bladder examinations) that included morning lectures in Morning Report, and clinical bedside training using Butterfly ultrasounds and hands on training in the Center for Simulation Education and Safety Research (CSESar).

As in years past, the Department of Medicine had a plethora of faculty receiving Exemplary Teacher Awards. A remarkable 36 faculty were recipients this year and are listed in the Honors and Awards section below along with the resident teaching award recipient, Dr. Maria del Mar Morales Hernandez. Dr. Jose Rivas Rios was a finalist for the Louis S. Russo Jr., Resident Award for Outstanding Professionalism. Dr. Belinda Bajric was a finalist for the Edward Jelks Outstanding Resident Clinician Award and Dr. Maria del Mar Morales Hernandez was a finalist for the Rosilie O. Saffos Outstanding Resident Teacher Award. A comprehensive list of award recipients is included in the Honors and Awards section.

The residents presented to local conferences of the Duval County Medical Society Annual Meeting and the UF College of Medicine Research Day in Jacksonville. Presentations were also made at regional conferences that included the Florida Chapter of the American College of Physicians Meetings, Miami Valves Meeting, Florida Chapter of the American College of Cardiology, Florida Medical Association, American Federation for Medical Research Southern Region, Society of Hospital Medicine, and Southern Hospital Medicine. Residents even presented at prestigious national conferences that include American College of Cardiology, American Thyroid Association, American Society of Nephrology, and the American College of Gastroenterology meetings. Residents continue to produce a high volume of scholarly activity that included presentations, publications, abstracts, and grants.

The internal medicine residency continues to make curricular changes to meet the new ever changing landscape of Graduate Medical Education. The program made significant strides in ultrasound training. The online learning platform and curriculum continued to develop under the leadership of our chief residents, Kevin Green and Pete Staiano, as well as our faculty Dr. Brittany Lyons and Win Aung. Point of Care US (POCUS) became more available with the addition of hand held ultrasounds, and this has significantly increased the experience residents have in diagnostic ultrasound.

The medical student experience in the Department of Medicine has continued to thrive with Dr. Elisa Sottile as the Clerkship Director for the Jacksonville campus. Dr. Sottile meets with students individually, provides feedback, facilitates their self-reflection, and plans for growth. As a member of the UF College of Medicine Regional Medical Campus Task Force, Dr. Sottile helped fashion innovative changes to the student curriculum to provide an opportunity for learners to better understand health systems science as well as how the social determinants of health impact their provision of care to an underserved population. The campus continued to grow in terms of the number of students coming from other medical schools to do elective rotations. These students rotate on internal medicine, inpatient cardiology, MICU, endocrinology, infectious disease, and nephrology. Many of these students interviewed with us and eventually matched to become residents.

This summary would not be complete without some notation about the difficulties from the COVID-19 pandemic. All programs were required to make rapid and drastic changes to nearly every aspect of health care and education. The divisions will reference the clinical aspect, but the educational mission was met with several threats that needed to be dealt with promptly. First, the conferences and lectures were changed to a virtual format. A number of new technologies were introduced to be able to enhance the teaching experience, including Zoom, Poll Everywhere, cameras, microphones, and iPad technology. Residents and Fellows quickly adapted to virtual health care visits. Despite cancellation of all local, regional, and national conferences, trainees continued to pursue scholarship. Many of the conferences became virtual and many started accepting electronic abstract submissions. As one might expect, although there was not yet an increase in cases of COVID-19 at our institution, there was significant stress on all physicians, especially residents and fellows. The program and department leadership recognized this and began to address this. The core residency program adapted to the changes well in all the facets of training, healthcare, and well-being while maintaining cohesiveness.







#### DEPARTMENT RESEARCH ACADEMIC YEAR 2020 (7/19 - 6/20)

The faculty in the Department of Medicine continue to obtain research awards and train future investigators; an important aspect of the University of Florida College of Medicine-Jacksonville's mission. Trends in external funding for fiscal year 2019-2020 and three prior years are shown in **Figure 1**.



External funding from federal, state, industry, foundation and other sources decreased 31% this fiscal year compared to last. This occurred even though there was an increase in the number of funded investigators, from 23 investigators last fiscal year to 26 investigators this fiscal year (**Figure 2**). However, the number of funded projects declined from 93 last fiscal year to 81 this fiscal year (**Figure 3**).



# **#** Funded Investigators

Several faculty members in the Department of Medicine have basic/translational science projects in the Medical Research Building. **Michael Haas, Ph.D.,** (Endocrinology) is investigating molecular mechanisms that regulate expression of genes involved in cholesterol transport and the integrated stress response in human coronary artery endothelial cells. **Kent Wehmeier, M.D.,** (Endocrinology) is investigating the effects of nicotine on cellular stress in smokers and in human coronary endothelial cells and studying apoptosis in osteocytes. **Charles Heilig, M.D.,** and **Yongxin Gao, M.D.,** (Nephrology and Hypertension) are examining the regulation of glucose transporter 1 expression by mechano-growth factor as well as examining the role of glucose transporters in liver cancer.

Residents and sub-specialty fellows in the Department of Medicine are assigned a mentor and participate in basic, translational, quality improvement research, epidemiological, or clinical research. At the Celebration of Resident and Fellow Education and Research Awards, residents **Dr. Taylor Palfrey, M.D.**, received the Rosilie O. Saffos Outstanding Resident Teacher Award and **Dr. Khadeeja Esmail, M.D.**, received the Edward Jelks Outstanding Resident Clinician Award. Resident **Dr. Belinda Bajric, M.D.**, was nominated for the Edward Jelks Outstanding Resident Clinician Award. **Research:** Our faculty continues to excel in research, scholarly production and participation in national and international scientific sessions. We have approximately 50 ongoing studies, which range from basic/translational research to large scale clinical trials in various areas of cardiovascular disease. These include investigator initiated as well as sponsored studies. We have published approximately 50 peer-reviewed manuscripts, 1 book chapter, numerous abstracts and presentations at local, national and international meetings. We currently hold leadership positions in most major cardiovascular societies and editorial positions in many major cardiovascular journals. We continue to receive consistently increasing extramural funding. Our research staff has also expanded to meet the demands of our growing research operations following our recent relocation to a new cardiovascular research building which hosts a state-of the art thrombosis research laboratory, patient waiting area, clinical visit rooms, and offices for research staff.





#### DIVISION OF ENDOCRINOLOGY, DIABETES AND METABOLISM ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

The Division of Endocrinology, Diabetes and Metabolism had a year of sustained change and development in all areas of the academic mission of the University of Florida. Clinically, major events included expansion of clinical services geographically and provision to a broader audience including the growth of virtual visits as a way to provide care to patients during the COVID-19 crisis. Academically, the Division submitted multiple manuscripts, delivered multiple scholarly presentations and contributed to the university's educational mission.

Patient care: The Division provided inpatient and outpatient consultation on site and virtually at the University of Florida College of Medicine-Jacksonville campuses and Emerson Medical Plaza to faculty of the university and referring physicians in the northeast Florida/southern Georgia region and beyond. The UF North campus extends endocrinology services to a broader area of the First Coast. The core clinical faculty of the Division include Dr. Joe Chehade, Dr. Marilu Jurado, Dr. Gunjan Gandhi, Dr. Arshaq Mooradian, Dr. Leena Shahla and Dr. Kent Wehmeier. The Division addressed clinical endocrinology problems related to hypothalamus, pituitary, thyroid, pancreas, adrenal and sex hormone gland dysfunction as well as gender identity. Patients with metabolic disorders including diabetes mellitus, metabolic syndrome, obesity, anorexia, hypercholesterolemia, calcium and metabolic bone diseases such as osteoporosis and vitamin D deficiency were evaluated and treated. The Division's main clinical operations occurred at UF Endocrinology and Diabetes at Emerson Medical Plaza. The number and variety of consultations continued to rise. Patients were also evaluated at the UF Health-Jacksonville Ambulatory Care Center (ACC) and at the UF Health North Hospital and Clinic primarily through the work of Dr. Gandhi Our faculty performed analyses of the glucose monitoring data, obtained by continuous and Dr. Shahla. glucose monitoring to make recommendations regarding diabetes management. Diabetes care has matured with the partnering of outpatient diabetes medical nutrition therapy with the Division of Kristina Worthington, MSH, RD/N, CSSD, LD/N provides onsite education at the UF Endocrinology. Emerson location and UF North for diabetes management, carbohydrate counting and medical nutrition therapy (MNT.) Dr. Chehade, Dr. Jurado and Dr. Shahla utilized ultrasound guidance for the evaluation of patients with thyroid nodules, parathyroid neoplasia, lymph nodes, and thyroid cancer to provide comprehensive care to patients with nodular disease of the neck.

A unique collaboration with the UF College of Medicine-Jacksonville's Department of Oral Maxillofacial Surgery, Surgery, Radiology and Pathology has enhanced the care of patients with thyroid and parathyroid disease. Through the discussion and implementation of diagnostic and treatment protocols, the care of these patients has been standardized to better evaluate outcomes and focus on patients with more challenging management issues.

The care of patients with pituitary or sellar tumors was also advanced through the collaboration of the departments of neurosurgery, radiology, pathology and otolaryngology. Through weekly conferences, challenging cases were brought to the group to provide unique diagnostic and treatment approaches for individuals with rare neoplasms and unique presentations.

On the inpatient service, more patients were served by endocrinology consultation. The Division also provided evaluation and management strategies in the areas of diabetes, thyroid disease and osteoporosis to UF Health Jacksonville and UF Health North to facilitate optimal care of patients with these conditions.

Leading the charge for better inpatient diabetes care, the Division's own Dr. Gandhi chaired the Diabetes Steering Committee. This multidisciplinary body comes together to discuss common issues in glucose control. Strategies to improve outcomes are discussed and implemented. **Education:** The Endocrinology fellowship continues to maintain its ACGME accreditation, under the direction of Program Director, Dr. Gunjan Gandhi and Dr. Kent Wehmeier as Associate Program Director. Dr. Russell Fung and Dr. Angela Richter joined the Division in July 2019. Dr. Poonam Kapadia and Dr. Shrina Parekh have been exceptional and productive additions to the Division and completed their fellowships June 30, 2020. All four fellows have made substantive contributions to the clinical care, education and research mission of the Division. In resident physician education, Dr. Wehmeier continued as rotation director of relevant educational programs for Endocrinology. He is the primary liaison between the Core Residency Program and the Division, and is a member of the Resident Education Committee. The faculty members and fellows participate in teaching rounds in the clinic and in conferences to enhance the experience of the rotating residents.

In the educational program of the University of Florida, Dr. Chehade, Dr. Gandhi, Dr. Mooradian, Dr. Jurado, Dr. Shahla and Dr. Wehmeier precept trainees at UF clinics in Endocrinology and coordinate lectures for the University of Florida medical students and residents in medicine. The Division of Endocrinology Grand Rounds provides an avenue for speakers at UF Jacksonville and Gainesville to share knowledge and enhance collaboration between various disciplines at UF. Dr. Chehade, Dr. Gandhi, Dr. Haas, Dr. Jurado, Dr. Mooradian and Dr. Wehmeier were chosen to receive the 2020 University of Florida-College of Medicine's Exemplary Teachers Award under Education.

**Research:** Strides have been made in making clinical research more attractive to industry and to potential subjects. Under the guidance of Division members, the awards and numbers of subjects have continued to grow. Additional research staff has been added to grow the Division's efforts. The research has involved the use of devices to control diabetes mellitus, pharmacologic agents for glucose management, diabetic neuropathy, non-alcoholic fatty liver disease and metabolic bone disease. Dr. Joe Chehade is also spearheading a clinical trial in the new Jacksonville Aging Studies Center or JAX-ASCENT. This site will serve as a hub for aging research in the Northeast Florida/Southeast Georgia area. The basic science research lab, under the direction of Dr. Michael Haas, continues to be a place of learning and scholarly activity. Investigations regarding the effects of multiple hormones on the expression of the most important protein in the high density lipoprotein (HDL) particle, Apo AI, and the involvement of endoplasmic reticulum (ER) stress and oxidative stress in coronary artery disease continue to reveal critical insights.

**Service:** Leading the charge for better inpatient diabetes care, the Division's Dr. Gandhi chairs the Diabetes Steering Committee. This multidisciplinary body comes together to discuss common issues in glucose control. Strategies to improve outcomes are discussed and implemented.

**Philanthropy:** The Division members have been the recipients of many gifts. In the spirit of giving back, the members have contributed their time, effort and resources to the underserved and to children in Jacksonville, as well as overseas.

## DIVISION OF GASTROENTEROLOGY ACADEMIC YEAR 2020 (7/19-6/20)

# Highlights

Gastroenterology Division has built an inter-disciplinary team of faculty, advanced practitioners and nurses. Our faculty members were Dr. James Scolapio, Dr. Faisal Bukeirat, Dr. Ron Schey, Dr. Bruno Ribeiro, Dr. Neha Agrawal, Dr. Robert Bass, Dr. Paul Sievert and Dr. Peter Ghali. The allied health professionals included Victor (Pat) Nasrallah, Rhonda Broughton, Mei Lyn Lamar, as well as our nurse William Ecker. Our Division responded well to challenging clinical environments due to the pandemic. Working closely with our surgical colleagues, we continue to have one of the premier upper GI tract disease centers in the state. Our endoscopic ultrasound activity has more than doubled and we have added new diagnostic tools such as EndoFLIP and Digitrapper, which have made us a referral destination for a wide catchment area. Our hepatology program has also more than doubled in activity with a much closer integration with the Gainesville transplant group. Our Fellowship program remains strong and is academically productive. We would like to thank every team member for going the extra mile to take care of our patients and each other.

**Patient care:** The patient care aspect of our academic mission is pursued at the following locations: UF Health North with general GI clinics and endoscopy, Emerson campus, where we provide general gastroenterology, inflammatory bowel disease, and hepatology services, Towers clinic with general gastroenterology and hepatology clinics, UF Beaches with general gastroenterology clinic. Endoscopy is performed at three clinical sites: UF Health Downtown, UF Health North, and Jacksonville Beach Surgery Center. Inpatient consult services are provided at UF Health Downtown as well as UF Health North. Our mission is to have timely patient access to top quality patient care with specific attention to reduced patient wait times and increased access to high-quality gastroenterology and hepatology services in any of our locations.

**Education:** Dr. Ghali as the Program Director of our fellowship training program has maintained a high quality of trainees' satisfaction based on the 2019-2020 ACGME survey which showed that our program overall fellow satisfaction is above the national average with 100% evaluating the program as positive or very positive. 100% of the gastroenterology faculty also evaluated the program as excellent or good. Our fellows' board pass rate has consistently been 100%. Our priority remains recruiting gastroenterology fellows with a proven track record of clinical research as well as commitment to superb patient care, interpersonal skills and professionalism. We continue to be very active at the Jacksonville Gut Club quarterly meetings. This educational venue is very important to our division's presence in the community. We have reacted to the COVID-19 pandemic. We discussed the challenges with each other, with our fellows, and with our staff, and we are all involved in improving the processes to promote physician well-being.

**Research:** All faculty members have been productive in scholarly activities over the past academic year. The Division produced twenty-one peer-reviewed published manuscripts, ten abstract presentations, and four book chapters. The GI faculty have given multiple presentations at local, regional, national, and international meetings. The Division now has eleven funded research protocols and was able to generate over \$700,000 in grants last year.

## DIVISION OF GENERAL INTERNAL MEDICINE Academic Year 2020 (7/19-6/20)

# Highlights

The division continues a robust inpatient and outpatient practice and is an integral part of the educational experience for the Internal Medicine residency.

**Patient Care:** The Division of General Internal Medicine is comprised of 19 members, including the two chief medical residents and two PhDs. All full time clinical faculty are certified by the American Board of Internal Medicine. The clinical care provided by members of the division include the provision of inpatient care as the attending for the four inpatient teaching services and an inpatient Internal Medicine consultation service, including medical evaluation of patients admitted to the inpatient Psychiatry service. Drs. Brittany Lyons and Win Aung, who oversee the medicine consultation service, are trained in bedside ultrasound guided procedures. The procedural service is available to other services to ensure the provision of safe care.

The group has a busy outpatient practice offering services at three locations: the Ambulatory Care Center (ACC) at UF Health Jacksonville, the UF Internal Medicine Clinic at Emerson Multispecialty Clinic and the General Internal Medicine Clinic at UF Health North. Based on patient satisfaction, the physicians in the group are considered excellent clinicians. In addition to the excellent physicians in the group, the outpatient primary care practices are certified as NCQA Level 3 Patient Centered Medical Homes. Our outpatient practices offer two unique clinical initiatives. The *PAIDD* (Program for Adults with Intellectual and Developmental Disability) clinic established in 2013 provides primary care services and care coordination to adults with special needs who are unable to manage their health independently. *PAIDD* providers, Drs. Edwards and Jacob, provide care to almost 200 adults with intellectual and developmental disabilities. RN care coordination of these patients has been supported by a grant from the Jess Ball DuPont Foundation. The second unique clinical initiative is acupuncture services offered by Dr. Alan Halperin. Alternative treatment options for management of pain is critical. Dr. Halperin's acupuncture clinic offers a viable alternative.

Our four inpatient teaching services are supervised by two teaching hospitalists, Drs. Aung and Reddy and other members of the Division of General Internal Medicine. The four teaching services provide an excellent educational experience for the internal medicine residents as well as residents from anesthesiology, psychiatry preliminary residents in neurology. Medical students from the University of Florida College of Medicine and other non-UF medical schools have an opportunity to work alongside an excellent group of teaching faculty and residents. As part of the inpatient wards and consultation service, residents and medical students learn the use of bedside ultrasound to assist in diagnosis and in performance of procedures. Drs. Lyons and Aung have prepared a comprehensive curriculum using simulation training to assess their skills and pre- and post-tests to assess the knowledge. During the coronavirus pandemic, the teaching services cohorted patients with COVID 19 on two services to reduce faculty and resident exposure risk and ensure consistency with treatment. The GIM faculty were instrumental in developing order sets and treatment algorithms for patients admitted with SARS-CoV-2

The division has two faculty members with training in hospice and palliative care: Dr. Ravindra Maharaj and Dr. Win Aung. Dr. Maharaj also holds a certificate of added qualifications in geriatrics. Along with a growing outpatient geriatric practice and palliative care practice, Dr. Maharaj offers hospice and palliative care services to our inpatient services. He is providing a much needed service, as well as education, on the role of palliative care and hospice in the care of our patients. During the pandemic, the services of hospice and palliative care have been critical as physicians, patients and families made difficult decisions.

**Education:** As noted above, resident and student education are woven into the division's practice. The GIM faculty provide supervision of residents on the four general internal medicine inpatient teaching

services, the inpatient medicine consultation and procedural service and geriatrics and hospice and palliative care. In addition, the members of the division provide faculty supervision and mentoring of all categorical medicine residents in their outpatient continuity practice and urgent care clinics. Members of the division participate in morning report, morbidity and mortality conferences and present at the noon conference core curriculum series held daily, as well as a Friday afternoon board review.

Dr. Jeff House serves as Program Director for the Internal Medicine Residency Program and Drs. Elisa Sottile and Carlos Palacio are the Associate Program Directors for the training program. The GME leadership mentors residents in their scholarly work and each year, the number of posters, abstracts, presentations and manuscripts increase. Dr. House has developed a unique rotational and curricular experience for the PGY2 residents that immerse them in quality and safety. This educational experience is well received by the residents and has resulted in quality improvement projects and scholarly activity. Dr. Sottile also serves as the Clerkship Director for medical students from Gainesville who rotate on the Internal Medicine service (inpatient and outpatient).

Drs. Brittany Lyons and Win Aung have developed a bedside ultrasound curriculum for residents as well as a weeklong emersion in a bedside ultrasound course for the interns in the residency program.

Drs. Masri and Sottile serve as peer reviewers for the University of Florida College of Medicine-Jacksonville faculty development program. Dr. Sottile also serves as a facilitator and is the co-developer of the "Residents and Fellows as Teachers"-a 6-8 hour intradepartmental seminar offered each year at the University of Florida College of Medicine-Jacksonville to first year residents and fellows.

The faculty in the division serve as program directors, speakers and workshop facilitators for the annual Update in Internal Medicine. Due to the coronavirus pandemic this excellent CME conference was cancelled but will return in the AY21. It is an excellent opportunity for local and regional healthcare providers to obtain CME and learn the most current information on interesting and hot topics.

The division serves as an integral part of the education program for 3<sup>rd</sup> and 4<sup>th</sup> year medical students, as well as physician assistant students, from the University of Florida. Members of the division serve as preceptors for students in both the inpatient setting as well as in our outpatient practice. Student evaluations of their experience are excellent and are reflected in the number of exemplary teacher awards given to faculty within the division each year.

**Quality:** Dr. Jeff House coordinates Quality Improvement (QI) for the Department and for the training program. Dr. House is the Associate Chair of Medicine for Quality and Education. He is the Chair of the Medical Performance Improvement Committee (MPIC) and is a member of the Performance Improvement Committee-the institutional body that oversees quality and safety for the UF Health Jacksonville campus. Dr. Jacob serves on MPIC as the GIM representative. The division has focused on readmissions and patient satisfaction this past year. Due to previous work by QI teams in collaboration with case management, GIM readmission rates have dramatically improved. The division continues to address timeliness of discharges and through put, as well as identify opportunities to continue to improve our patient satisfaction. In the outpatient setting, Dr. Palacio coordinates a number of quality improvement projects with the residents to look at access, show rates and whether preventive care and screening guidelines are being met. The use of quality dashboards in EPIC has allowed our practice to improve its cancer screening and immunizations and to reduce care gaps in our patient population. The GME leadership has worked with our EMR team to develop a resident dashboard that will be launched in July. This dashboard will be used as an education tool for residents to review their personal performance on various quality metrics and social determinants of health as well as review their performance compared to their peers in continuity clinics.

**Research:** Research in the division varies among the faculty. The development of the bedside ultrasound curriculum and the quality improvement/patient safety block rotation have led to poster presentations and other opportunities for educational scholarship. Many of the faculty mentor residents in their research projects and have assisted them in preparing and submitting case reports to the American Federation of Medical Research. The division continues to be productive as demonstrated by the publication list below.

Future Directions: To meet the primary care needs of Jacksonville, we expanded our practice to North Jacksonville and our practice continues to grow there, meeting the needs of this sector of Jacksonville and Duval and Nassau Counties. Our practice at the Southside Multispecialty Clinic also continues to grow and receives referrals from our specialty colleagues who practice at that location as well. The PAIDD clinic for adults with intellectual and developmental disabilities receives referrals from Northeast Florida because of the unique service provided to our special needs population.

The division, along with our residents will have the opportunity to develop performance improvement initiatives that will lead to improved patient care and safety and result in the preparation of scholarly works. The faculty and residents developed a handoff tool that is used for patients who are transitioning from the critical care unit to the floor to ensure that a safe transition occurs. And as noted above, a resident quality metric and social determinants of health dashboard has been launched and will serve as an opportunity for educational and quality research.

## DIVISION OF HEMATOLOGY AND MEDICAL ONCOLOGY ACADEMIC YEAR 2020 (7/19-6/20)

# Highlights

The Division of Hematology and Medical Oncology continued its clinical and academic missions during this past year. The division provides inpatient clinical consultation in hematology and medical oncology and maintains a thriving ACGME accredited oncology fellowship training program. Our division hosted and organized our third annual Breast Health Awareness Expo which expanded off campus into the community as planned. We increased our community support by actively participating in the American Cancer Society's; Making Strides against Breast Cancer Walk on Team "UF Health in the Pink Zone". We were able to successfully participate and host a Yoga event to help fundraise for breast cancer awareness month. We welcomed our newest faculty member and division chief; W JR Quan, from Loma Linda University. We look forward to a new, exciting year of clinical expertise, leadership and mentorship displayed in the expansion of our division along disease-oriented specialization.

**Patient care**: Our division continues to increase access to our inpatient and subspecialty experts in evaluation and treatment of hematologic malignancies. We provide both outpatient and inpatient consultative services for hematology and oncology at the downtown campus, which is also the location of the only sickle cell clinic in Jacksonville, Florida. Patient care is readily convenient at our many locations such as the UF Health Jacksonville campus, Ambulatory Care Center, and UF Health North campus. To provide the best quality of patient care, collaboration with multiple specialties through mechanisms including multi-disciplinary tumor conferences are ongoing. Our division has added a palliative care outpatient clinic twice per week that emphasizes alleviation of cancer-related pain and other symptoms. Our faculty members collaborate closely with the Proton Therapy Institute, the Department of Surgery, and Gynecologic Oncology. Faculty actively educate with patient education sheet facts; these are distributed by the physicians on different cancers. Our division continues to host the Oncology Pharma Expo quarterly. An Oncology support group has been created and hosted by the division's initial nurse navigator.


**Education:** The prior medical oncology fellowship became accredited by the ACGME as a new three-year combined hematology/oncology fellowship leading to dual board eligibility. The didactic curriculum has expanded to include twenty Hematology core lectures. Reviews for the fellows' in-service training exam were added along with several lectures including chemotherapy toxicity and 4 comprehensive breast lectures.

Our faculty offers a consult experience in hematology and oncology to residents at all training levels. This affords an opportunity for a measure of autonomy in order to build their skills and confidence going forward, while ensuring that prompt diagnostic and therapeutic decisions are made in the patients' best interest. Faculty development sessions including those on small group teaching, teaching under time constraints and others are essential to the educational growth of our division.

The division continues to support the Internal Medicine Residency Program through didactic approaches during night float rotation, Internal Medicine resident's noon conference, and Grand Rounds. The hematology oncology fellowship has rotations at Mayo Clinic Jacksonville (Bone Marrow Transplant, benign hematology). Fellows are active participants at a weekly lecture series which encourages and develops great teaching skills. Our monthly Journal Club is ongoing and generates discussion on various topics and the latest developments in hematology and oncology.


**Research:** The Division of Hematology and Medical Oncology continues to develop additional industry sponsored trials. The division is currently enrolling and actively recruiting for the Discovery Study as well as the Polaris study. Clinical studies in myeloproliferative diseases and lymphoma are anticipated in the coming academic year. IRB approval was given for a prostate cancer study that faculty and fellows have begun working on. Collaboration with UF Proton Therapy research trials continues. Our division continues to provide academic support to residents though mentorship in research endeavors.

## DIVISION OF INFECTIOUS DISEASE ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

The Division of Infectious Diseases continued its clinical and academic missions during this past year. The division is comprised of 4 university based infectious diseases consultants at the primary teaching hospital, all of whom are dually boarded in Internal Medicine and Infectious Diseases, with an additional 11 ancillary faculty composed of board certified infectious diseases physicians, doctoral level microbiologists and doctoral level pharmacists who are actively involved in various aspects of the fellowship training program.

The division provided inpatient clinical Infectious Diseases consultation at UF Health Hospitals/Jacksonville and North; Hospital Infection Prevention and Control and Antimicrobial Stewardship direction at UF Health Hospitals and outpatient infectious diseases consultation at the downtown Ambulatory Care Clinic, Emerson Campus Clinic and North Campus clinic. The division maintained an ACGME accredited Infectious Diseases fellowship training program and actively participated in the training of internal medicine residents and medical students in inpatient and outpatient infectious diseases.

Members of the division also assumed administrative and teaching roles in the ID division and IM activities. Dr. Sands is the university ID Division Chief, ID Fellowship Associate Program Director and the Medical Director of Hospital Infection Prevention and Control for UF Health Hospital. Dr. Isache is the Chair of the Antimicrobial Stewardship Programs for UF Health Hospital and the ID Fellowship Program Director.

## Patient care:

<u>University ID Division inpatient and hospital based activity:</u> The division provided full time inpatient infectious diseases consultation throughout the UF Health Jacksonville Hospital system. During the 2019-2020 academic year, the division performed over 900 inpatient infectious diseases consultations with over1200 subsequent follow-up visits at UF Health Hospital.

<u>Outpatient services:</u> The division offered outpatient ID consultation by referral at the Emerson and the Ambulatory Care Clinic (ACC) subspecialty clinics. During the 2019-2020 academic year, there were over 450 outpatient ID visits for HIV/AIDS and general Infectious Diseases diagnoses including chronic osteomyelitis and MRSA infection.

## Education:

<u>Grand Rounds</u>: The division actively participates in presenting at Medical Grand Rounds and as regular attendees. This academic year faculty gave presentations at two UF Grand Rounds.

<u>Fellowship Training</u>: The division maintained an ACGME accredited fellowship in Infectious Diseases with one fellow for each of the two clinical fellowship years. The fellowship program has been reaccredited on a five-year cycle. The fellowship training is unique in offering two months of clinical microbiology, dedicated research time, two months of training in solid organ transplantation ID at the Mayo Clinic, one month training in Pediatric Infectious Diseases at Wolfson Children's' Hospital and one month as a junior ID faculty consultant in the UF Health MICU, in addition to 14 months experience as the consultant and teaching fellow on the general ID inpatient consult service at UF Health.

Our Infectious Diseases fellows continue to distinguish themselves through maintaining a 100% ID boards pass rate and achieving successful employment as full time Infectious Diseases consultants in a variety of metropolitan areas, including San Francisco, Atlanta, Baton Rouge, Tampa, Orlando and here in Jacksonville.

<u>Resident Training</u>: Faculty provided a 12 lecture series ID core curriculum conference for the residents; ID consultation teaching and clinical rounds; outpatient HIV/AIDS continuity clinics; and resident ID board review sessions.

<u>Medical Student Education</u>: Medical students from UF Gainesville, other US sites and internationally, rotate on the infectious diseases consultative service and the outpatient ID clinics at both the ACC and Emerson campuses.


<u>ID Division Conference Schedule:</u> The division maintained a full conferencing schedule with topics including: core infectious diseases topics, regularly scheduled case conferences; ID board reviews; monthly journal club; HIV topical reviews; monthly TB cases and topical reviews; monthly research conferences; travel and tropical medicine conferences; transplantation ID conferences; and monthly Med/Peds ID joint conferences.

<u>Cooperative extramural resident and fellows' training</u>: As part of their curricula, Mayo Clinic ID fellows, UF Intensivist fellows, UF Pediatric ID fellows and UF Podiatry-Orthopedic residents rotated on the UF ID inpatient consultative service and in the HIV outpatient clinics.

<u>Research</u>: Dr. Sands was the principal investigator on two NIH sponsored research grants through the INSITE network; the START and Smart studies, now completed, to define the appropriate time to initiate antiviral therapy for HIV-infected patients. Post hoc analyses of the data has continued to yield valuable results and publications.

Publications and presentations this past academic year included 16 journal articles published in peer reviewed journals, three published ID monographs, 4 presentations and 3 abstracts presented at regional and national meetings.

## DIVISION OF NEPHROLOGY AND HYPERTENSION ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

In the 2019 - 2020 academic year, the Division of Nephrology and Hypertension continued to make headway in meeting the goals of the academic mission.

In patient care, the offsite dialysis venture with DCI at the Gateway Unit has continued to support the hemodialysis mission for UF. ARNP's Melissa Goalen and Shatura Rowe played essential roles in the care of our large outpatient dialysis population. The DCI Midtown hemodialysis patients are planned to move to the nearby DCI Gateway and LaVilla Dialysis Units later this year, while the peritoneal dialysis patients will eventually move to the LaVilla Dialysis Unit.

In education, the Nephrology fellowship progressed successfully with continuation of Simulation Trainings and off-site renal transplant rotations. The Emerson site Renal Transplant Clinic has been up and running since June of 2019 with Dr. Vishal Jaikaransingh and Dr. Pradeep Kadambi seeing patients there. Dr. Vishal Jaikaransingh took over the Associate Program Director position, and organized the fellows' Renal Physiology Course.

The joint Renal Pathology Conference with Mayo Clinic Jacksonville and Mayo Clinic Rochester continued as a successful and important piece of the educational program, as did the Transplant Rotation at Mayo Clinic Jacksonville with a core lecture series. Our annual Update in Nephrology & Hypertension CME Symposium with grant support from Dialysis Clinics Inc., was deferred in 2020 due to the COVID19 pandemic. Dr. Ronald Mars received a Faculty Teaching Award this academic year.

The Division presented Mechano-Growth Factor (MGF) and glucose transporter research work on glomerular disease at the 2019 American Society of Nephrology meeting. This work included a new invention of MGF-Transgenic mice developed to study the pathogenesis of diabetic nephropathy. In addition, translational research describing GLUT1 gene SNP's associated with heavy proteinuria in patients progressing to ESRD was reported at the 2019 ASN Meeting. Fellow case report abstracts were also a part of the 2019 ASN Meeting. The research laboratory of Dr. Charles Heilig continued with funded basic research studies into the pathogenesis of diabetic and nondiabetic glomerulosclerosis in diabetic and transgenic mouse models, with a focus on the roles of Mechano-Growth Factor (MGF) and glucose transporters. Dr. Charles Heilig had research grant funding from DCI, Inc. and a Scott R. Mackenzie Foundation Research Grant for studies of glomerulosclerosis in mice. He also mentored Dr. Irtiza Hasan for a human glomerulosclerosis study funded with a UF Dean's Grant. Dr. Ljubomir Ilic had research funding from DCI, Inc. to study glucose transporter risk genotypes in patients who progressed to ESRD. Dr. Yongxin Gao, Assistant Scientist in the Nephrology Research Laboratories, continued her collaborative research work on glucose transporters, MGF and other growth factors in diabetic and nondiabetic kidney disease. Dr. Heilig gave an invited research presentation at the 2019 Southern Salt Water & Kidney Conference.

Fellows and/or faculty attended and participated in meetings of the American Society of Nephrology, the National Kidney Foundation, and a national Home Dialysis Educational Seminar.

**Patient care:** The Division of Nephrology provides physician services and the medical director for two outpatient chronic dialysis units and also provides services to the inpatient UF Health Jacksonville acute hemodialysis unit. Dialysis Services provided include both hemodialysis (HD) & peritoneal dialysis (PD). Faculty clinics are staffed at the Towers Clinic on the downtown campus by the nephrology faculty members, and at the Emerson Transplant Clinic by Dr.'s Vishal Jaikaransingh and Pradeep Kadambi. The nephrology clinics at the UF Health Jacksonville campus include the Nephrology Faculty Clinics, the Anemia

Clinic, the Post-Renal Transplant Clinic, the Fellows' Continuity Clinics, the Correctional Facility Clinic, the HD Outpatient Center and the PD Clinic. The inpatient Nephrology Acute and Chronic Consult Services are staffed by 2 faculty members and two fellows. These two services continue to provide important educational platforms for fellows, medical residents & students. Dr. Ronald Mars was the Quality Officer for the Division.

The Division has been working with the Department of Surgery on improving placement of permanent vascular access for patients preparing for hemodialysis, to fulfill goals of the Fistula First Program. The Post-Renal Transplant Clinic continued to serve as another platform for education of the fellows and care of patients previously transplanted at this program.

**Education:** The fellows' Renal Physiology Course, initiated in 2010, continued under Dr. Ilic's and Dr. Jaikaransingh's guidance as an important component of the nephrology educational experience. The joint Renal Pathology Teleconference including UF Health Jacksonville, Mayo Jacksonville and Mayo Rochester, has continued to be an important educational component for the Nephrology Fellowship program. The COVID-19 pandemic prevented the Update in Nephrology and Hypertension Symposium in 2020. Otherwise, this has been an important educational venue for fellows and faculty alike. This symposium typically includes UF faculty plus visiting speakers.

The Nephrology faculty continue to participate in educational programs for the Medicine residents, including the Night Float Rotation, Medicine Residents' Noon Conferences, Nephrology Clinics & the Nephrology Hospital Consult Rotations. The Mayo Clinic Jacksonville Renal Transplant Rotation for UF Health Jacksonville Nephrology fellows continued successfully and complements the Nephrology training program at UF Health. The ACGME-required milestones have been incorporated into the fellowship training program and rotation evaluations.

**Research:** The topics of research studies in the Division spanned from basic science work on glucose transporter & growth factor roles in diabetic and nondiabetic glomerular disease, to translational work genotyping ESRD patients for kidney disease risk alleles, and modified dialysis prescription investigation. Dr. Heilig's laboratory focuses on glucose transporter- and MGF- regulation of glomerulosclerosis in both diabetic and nondiabetic kidney disease. This laboratory continues to be funded from two outside sources. Dr. Ljubomir Ilic was funded for translational work investigating high risk genotypes for kidney disease in patients who progressed to end stage renal disease. Dr. Irtiza Hasan, Renal Fellow mentored by Dr. Heilig, was funded with a UF Dean's Grant to investigate mechanisms of glomerulosclerosis in patients with nondiabetic renal disease. Dr. Abdalagani Abakar Baher is working to build his clinic with plans for investigation of glomerulonephritis cases. In addition he participated in a clinical trial of genetics in hypertension in African Americans. Dr. Vishal Jaikaransingh participated in two clinical trials, one on ambulatory blood pressure monitoring, and another on COVID-19 and renal disease. Dr. Ronald Mars investigates the efficacy of modified dialysis prescriptions for cost saving in hemodialysis.

The Nephrology fellows participated in various different research studies & scholarly activities as part of their research training. Fellows also attended/participated in research activities for the 2019 American Society of Nephrology Meeting and the 2020 National Kidney Foundation Meeting. The Nephrology Division produced 4 manuscripts, 5 abstracts, 9 presentations, and 1 scientific invention. There were also 5 active grant awards in the Division this year (4 research grants & 1 education grant).

## **Special Initiatives:**

<u>Nephrology & Hypertension Annual Update, Jacksonville, FL:</u> This year's meeting was deferred due to COVID-19. This otherwise yearly meeting typically provides education and CME credits. Doctors, nurses and others involved in the care of patients with renal disease attend the meeting. The Activity Director is Dr. Ronald Mars.

<u>Nephrology Fellows' Quality Improvement Project in Dialysis:</u> The faculty worked with the fellows on this important activity which helped to fulfill the ACGME – required competency requirements.

<u>Nephrology Fellows' Patient Safety Project:</u> This Fistula-First Project includes, but is not limited to, fellow timely referral for and tracking of AV-fistula placement, outcomes from the time of referral to dialysis initiation and beyond. Goals include optimizing AVF prevalence and function for initiation of dialysis, reduction of vascular access complications once dialysis has begun, and fellow analysis of patient outcomes, by type of access initially used.

<u>Simulation Laboratory Experiences:</u> The Nephrology fellows received Institutional Patient Safety Training in the Simulation Laboratory. They also participated in the yearly Nephrology Simulation Laboratory experiences for temporary hemodialysis catheter placement and renal biopsy.

<u>Fistula First Initiative</u>: Faculty and fellows continue to participate in this quality improvement and patient safety initiative, aimed at improving patient outcomes on hemodialysis.

## DIVISION OF PULMONARY, CRITICAL CARE AND SLEEP MEDICINE ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

The Division of Pulmonary, Critical Care and Sleep Medicine has shown resilience thru a Global Pandemic with productive faculty members leading to the retention of our two graduating chief medical residents matching into our Fellowship program. The fellowship training program continues to be popular with over 400 applications for the two available positions per year. Clinically, we continue the expansion of Pulmonary Disease clinics and consultation services at UF North. Academically, the division continues to be productive in the areas of clinical and original research and publications. The faculty was involved as moderators and presenters for various sessions in Society of CHEST, Pulmonary Hypertension Association, SETA and ATS conferences. The fellows, under the mentorship of faculty, are engaged in a number of clinical studies, to include COVID-19 related studies. The division had a number of abstracts presented in national and international conferences and was represented in various national and international meetings in the form of providing educational lectures.

**Patient care:** The division faculty staffs a number of specialized and general pulmonary clinics. The asthma clinic, under the supervision of Dr. Cury, continues to be a part of the American Lung Association Asthma Clinical Research Network and involved in successful industry funded clinical research in this arena. The division continues to be involved with the community drives such as Lung Force uniting clinic and hospital staff with patients and loved ones to bring attention to Pulmonary disease states.

The pulmonary hypertension clinic, under the leadership of Dr. Seeram and Dr. Najjar, continues to be a locally known referral center with patients being referred from regions all over our coast. As member of the Pulmonary Hypertension Association, it is set to become a center of comprehensive care with a successful first site visit in December 2019. We sponsor a support group for patients and loved ones with Pulmonary Hypertension. The clinic currently manages over 200 pulmonary hypertension patients. Performing right heart catheterizations in a dedicated suite has led to excellent patient through put. The program has applied for certification as a Regional Referral Center under The Pulmonary Hypertension Association (PHA).

Janice Wood, RRT continues to be the Pulmonary Hypertension and Interstitial Lung Disease Program Coordinator.

Under Dr. Jones' supervision, the Interstitial Lung Disease and Sarcoidosis clinic continues to expand and is involved in numerous clinical trials in the area of IPF, to include the INBUILD trial that lead to approval for Nintedanib for progressive pulmonary fibrosis.

The fellows' continuity clinic is staffed by at least 5 fellows once a week and supervised by faculty. The number of pulmonary function, 6MWT, NIOX testing performed over both campuses has increased with the addition of a RT at North Pulmonary clinic.

The thoracic oncology clinic continues its multidisciplinary approach to patients with thoracic malignancy. The division successfully initiated the interventional pulmonary program at the North campus under Dr. Hadi Hatoum. The already extensive interventional pulmonary program with EBUS and navigational bronchoscopy for peripheral lung lesions continues to grow with all 6 fellows obtaining certification in navigational bronchoscopy.

The MICU was determined to be the unit for COVID-19+ critically ill patients for the pandemic surge. Our faculty stood up a 24/7 service to provide care without hesitation. The dedication, courage, professionalism has gone unmatched to our faculty, MICU nursing, and axillary staff.

The inpatient pulmonary consult service continues to be busy and, with the continued evolution of the bronchoscopy, thorascopic and right heart cath suite and the number, efficiency and timeliness of procedures offered by the division has been enhanced with the addition of advanced technology across both campuses. The COVID+ non-ICU patients have been consulted to the pulmonary service for recommendations on management and continuity of care.

**Education:** The faculty has been invited to present lectures at international conferences such as CHEST, ATS and SETA in the past year, which is a reflection of national recognition of our division.

The division continues to play an active role in educational core lecture series including Grand Rounds and Updates in Internal Medicine 2019. The division faculty also has an active role in the educational lectures for a variety of residency programs including Navy family medicine, emergency medicine, obstetrics, internal medicine and trauma critical care. Drs. Cury, Seeram, Hatoum and Jones were honored by University of Florida College of Medicine with the Exemplary Teacher Awards for 2019. Dr. Seeram was honored by University of Florida College of Medicine with Teacher of Year Award for years 2016, 2017, 2018 and is nominated again in 2020.

After a decade of educating and mentoring young Pulmonary and Critical Physicians, Dr. Cury passed the torch of Fellowship Program Directory off to Dr. Vandana Seeram in 2019. She has continued coordinating the educational activities for the fellowship with continued 100% first time board pass rates.

The division was involved in various regional/national/international meetings with faculty representing the University of Florida College of Medicine-Jacksonville by providing educational lectures in various topics of interest.

The faculty continues to mentor and supervise family medicine residents from the Navy residency program during their rotation in medical intensive care unit and have always received very positive feedback from the leadership of Naval Air Station Jacksonville. We have been active in training nurse practitioners and physician assistants not only from the University of Florida sponsored training programs but also from local sponsored programs.

**Research:** The division has been very successful in obtaining and continuing its clinical research trials along with funded research. The funded research includes dean's grants, UF clinical quality grant and investigator initiated trials. The number of internal unfunded clinical research protocols has also increased substantially resulting in quality abstracts being presented at national and international meetings. A dedicated clinical research coordinator, Fallon Wainwright, has enabled the division to participate in more collaborative based clinical research protocols including sleep medicine and rheumatology.

The faculty has had a number of publications in peer review journals and has manuscripts in preparation. Close collaboration with other departments with common research interests is the key to future protocols and publications.

## DIVISION OF RHEUMATOLOGY AND CLINICAL IMMUNOLOGY ACADEMIC YEAR 2020 (7/19 - 6/20)

# Highlights

The Division of Rheumatology and Clinical Immunology had a successful and productive academic year on multiple levels. We have seen some of the fruits of our dedication to the University of Florida College of Medicine–Jacksonville (UFCOM-J) mission. The division is grateful for the continued guidance of our leadership, including our Chairman, Dr. Arshag Mooradian. The Division had significant accomplishments in patient care, research and education.

The Division continues to work with other training programs and the GME office at UFCOM-J in order to provide mentoring and teaching for many students and residents who are interested in our specialty. The current Rheumatology fellowship started with the first fellow, Jaspreet K Kaler in July 2018. Dr Kaler has now graduated and has started private practice in Washington State. The Division organized the extremely successful 11<sup>th</sup> Annual CME Musculoskeletal Ultrasound training course. National and international Rheumatologists as well as fellows in training attended the course.

The Division has been successful in recruiting faculty members. However, the backbone to our success is the loyal and hardworking staff at our clinics, hospital and administrative offices. During the COVID pandemic, faculty, fellows, clinic and administrative staff worked hard to rapidly adapt to virtual visit practices to allow continuity of care of patients.

**Patient care:** The Division maintained its clinical volume and growth for the majority of the academic year. Despite the challenges posed by COVID 19, the division was successful in minimizing loss of patient access to care. Patient encounters include, but are not limited to, many types of arthritis, lupus, scleroderma, myositis, autoimmune and systemic diseases, osteoporosis, connective tissue diseases related to inflammation and metabolic dysfunction, soft tissue conditions and pain such as fibromyalgia. We continue to be on the forefront of providing very up to date rheumatology services and 24/7 consultations at UF Health Jacksonville Main Campus and UF North Campus, the Ambulatory Care Clinic and our dedicated outpatient clinic on Emerson Street. The Division also provides musculoskeletal ultrasound services related to rheumatologic care both for inpatient and outpatient settings.

In the outpatient setting, we provide full rheumatology coverage from Monday through Friday, where we provide diagnostic musculoskeletal ultrasound and musculoskeletal procedures under ultrasound guidance.

Excellence is our only goal when it comes to patient care. Our faculty members achieved or exceeded the average in our specialty and in comparison to others at our institution. We touch our patients' lives during some of the most vulnerable moments they will ever encounter alone or with their loved ones. As physicians of the UFCOM-J, we always strive for excellence in our practice.

**Education:** Education is one of the main missions at the UFCOM-J. Our faculty members have been very dedicated and creative in delivering the best of what they can offer to our students and residents. Our achievements in education were highlighted in multiple venues and the rheumatology fellowship program was a major cornerstone in the growth and development of our academic program. The Division has successfully attained fellowship accreditation starting in July 2018. The fellowship provides a strong clinical focus as well as many opportunities in clinical research, quality improvement as well as musculoskeletal ultrasound.

In the educational program of the University of Florida medical students and residents, Dr. Ramrattan, Dr. Thway, Dr. Ramsubeik and Dr. Kaeley participated in precepting clinics in rheumatology and delivered core

curriculum lectures for the Internal Medicine Residency Program. Faculty members participated in internal medicine Grand Rounds and shared the knowledge as invited rheumatology speakers on a regular basis.

The 11<sup>th</sup> Musculoskeletal Ultrasound Course in March 2020 was a great success. This 3-day CME handson training course uniquely utilized our state of the art simulation laboratory at the UFCOM-J. Dr. Kaeley organized the course and served as faculty, providing lectures and practical ultrasound instruction. Dr. Ramrattan served as a faculty member. Dr Thway served as the assistant course director, anatomy instructor. Dr Zareen Vaghaiwalla, PGY4 Fellow, served as an anatomy proctor and instructor. Rheumatology educators and fellows attended the course from 26 States, as well as from Canada. The attendees were very complimentary of the innovative cadaver-based curriculum held in the UFCOM-J CSESaR Simulation Center. An eLearning component complimented the course. Faculty have also produced eLearning material featured on national websites and are deeply involved in Musculoskeletal Ultrasound education nationally and internationally. Some of the international courses have utilized cutting-edge models produced by the UFCOM-J simulation center. The Division is grateful for the hard work of the simulation staff in making the courses such a success. The Division has also been heavily involved in musculoskeletal ultrasound advocacy by assisting the American College of Rheumatology and Florida Society of Rheumatology in coordinating efforts to interact with Medicare representatives.

E-Learning is an entrepreneur unique project that was pioneered by Dr. Kaeley. The aim of this project is to develop electronic learning content to cover basic Rheumatology Core Curriculum, as well as musculoskeletal ultrasound training material. Dr. Kaeley has successfully deployed Canvas to enable enhancement and deep learning with the fellowship program. The division has also undertaken novel organizational tools such as Trello to improve efficiency.

**Research:** The Division has been growing its research enterprise. Although the Division is active in numerous pharmaceutical trials, its emphasis is to develop investigator-initiated trials as well as to seek grants. The division has a strong guality improvement program as well as collaboration with the Pharmacy department, which has resulted in poster presentations at the Annual Meeting of the American College of Rheumatology. The division has also started projects with the UF Health Emergency Department. The Division has collaborated with multiple national renowned researchers. Of note, the Division collaborated with University of Alabama to develop skills in meta-analysis resulting in a publication. The Division continues to collaborate with the University of California, Los Angeles Division of Rheumatology in a bicenter prospective trial of Tocilizumab in Rheumatoid Arthritis, utilizing Power Doppler as a secondary outcome measure. In addition, the Division has collaborations with the Women's Hospital, Toronto as well as University of Ottawa as part of an international effort to develop a musculoskeletal ultrasound enthesitis diagnostic tool. The Division has also been evaluating Medicare Expenditures for Musculoskeletal Ultrasound as well as drug utilization. The division had multiple poster presentations at the American College of Rheumatology annual meeting in Atlanta, GA. Members of the Division are closely involved with the Outcome in Clinical Rheumatology Trials (OMERACT) musculoskeletal ultrasound group and is leading the project at developing sonographic outcome tools in psoriatic arthritis and dactylitis.
